
## 2024-25 State and Territory Nomination Program Allocations

- Australian Government issues allocations to states and territories every year.
- Tasmania's allocation of 2,860 places is over double the places we were provided last year.
- We received 3,425 Registrations of Interest (ROIs) last year. Already received 1,282 this year (since 1 August).
- Nomination allocations are different to the "visa planning levels".
- Each nomination leads to a visa application (maybe more if dependants). If granted goes toward the planning level.
- Visa processing times and backlogs have dropped over the last year, due in part to the low nomination numbers from last year.

#### **ROI** and Application Update – at 2 September 2024

- We have invited all Green pass holders from last year
- 844 ROIs on hand
  - Subclass 190 431
  - Subclass 491 413
- Indicates program will be very competitive
- Oldest application not allocated for processing lodged on 01 August 2024


### **Orange-Plus Priority Attributes**

 New category of priority attributes – intends to provide more clarity around invitations

 Some Green priority attributes now Orange-Plus

High priority for nomination

If claiming Orange-Plus attribute(s), ROI pass colour will only be Orange



#### **An ROI Explainer**

- ROIs are automatically ranked competitively by the Gateway system
  - Rankings based solely on priority attributes claimed within ROI
  - The more priority attributes claimed, the more competitive an ROI is
- Only the highest ranked ROIs are invited for nomination
- Priority attributes are listed on our website in order of importance – higher to lower
- ROIs are not assessed by anyone at Migration Tasmania
- If ROI is invited and claims were accurate, nomination should be approved
- Review your ROI to ensure you are claiming all possible priority attributes
- Check the guidance on our website "Additional information, exclusions and definitions"




#### **Overseas Candidates**

- Currently not selecting overseas candidates for 491 (OSOP) Invitation Only pathway
  - ROIs remain closed for this pathway
  - Invitations come through SkillSelect if we run a selection round
  - More information will be posted prior to conducting selections
- Overseas job offer in 491 Legitimate job offers are eligible
- Health Sector Job Offer pathway is open and will be considered for 190 nomination



#### **Selected Policy Clarification**

- Policy clarification can be found in the Additional Information pages of website
- Guidance around indicators of skilled employment:
  - Roles that match ANZSCO 1-3 Skill Levels
  - Pay rate above the TSMIT
  - Pay at or around minimum wage is NOT considered skilled employment
- Genuine employment indicators of concern
  - Heavy reliance on temp visa holders
  - Multiple nominations over several years
  - Inconsistencies between payslips and salary deposited into bank statements



### **False Claims/Fraud**

- No tolerance for fraud/false claims
- If claims in ROI / application not true we will refuse nomination
- If we find out after nominating, we will provide details to Home Affairs and withdraw nomination
- Fraud may affect future visa applications
